STATEMENT OF WORK (JUNE 2007)

On Page 8:

We are deleting the word "Furnishing" and adding the following SCC will provide mulch and pine needles.

~~Furnishing~~, hauling and distribution of the bark and needles will be the responsibility of the Contractor as part of this contract SCC will provide mulch and pine needles.

The Contractor shall furnish appropriate fescue seed for fall over seeding as required.

On Page 10:

Adding an item:

T. Aerate and overseed fescue and fescue blend turf areas in accordance with the typical schedule (coordinate with the SCC Grounds Supervisor). Use core type aerator and apply seed at a rate of 5 lbs per 1000 square feet.
