ACKNOWLEDGE RECEIPT OF THIS AMENDMENT

The following are added Specifications to the Clearing Project:

1. All underbrush and trees with caliper of 2-inches and smaller within the perimeter shall be removed and cut flush to the ground.
2. All hardwoods and select marked pines within the perimeter shall be removed and stumps cut flush to the ground.
3. All trees stumps and plant materials outside the perimeter with caliper of 2-inches or larger shall have stumps ground. All other material shall be mowed or otherwise cut flush to the ground.
4. All remaining trees shall be limbed neatly to a height of 18 feet measured at the base of the tree.
5. All grindings, mulch, and chips may be left piled in convenient locations on the site or may be hauled away at the discretion of the contractor.
6. Existing piles of dirt and debris may be removed or spread uniformly on the site with debris raked & chipped/removed at the contractor's discretion.
