**Listed below are the responses to the questions received by the designated date:**

Q. 1. Does the stone work need to extend 6" below the fill in grade?

A. 1. The stone work is to extend a minimum of 6" below the top of the dirt mound base.

Q. 2. Does Lentil or steel need to be provided to support masonry work?

A. 2. A horizontal lentil or steel member is to be installed at the base of the concrete work as an additional support for the masonry work.

Q. 3. Is the fill in and landscaping to be performed by SCC?

A. 3. The 2' height dirt mound base and landscaping is to be performed by SCC.

Q. 4. We certainly appreciate your consideration to expand the distance to 100 miles as we would like to bid on your upcoming sign needs.

A. 4. We will continue with the 75 mile distance.

Work must be performed in accordance with the SCDOT Encroachment Permit posted on our website.
