Listed below are the responses to the questions received by the designated date:

Q. 1. Trucks we are bidding are 230 miles away in Carrolton GA. Is that going to be an issue since the trucks are not 200 miles from the delivery site?

A. 1. Mileage is based on the Radius from Duncan, SC rather than Linear mileage

Q. 2. On the rust requirement. Are you guys looking to be 100% no rust on the truck frame? They are used trucks and the price range has us looking at 5-6 year old trucks they are going to have surface rust. If there is rust on the frame is that going to kill the bid?

A. 2. Minimal surface rust on the frame and/or body are considered acceptable. However, any indication of rust through any portion of the frame will immediately disqualify the vehicle, and minimal rust on the body (size of one US Quarter or smaller) are acceptable.
