Listed below are the responses to the questions received by the designated date:

Q. 1. I am inquiring about the bid to wrap the trailers and box truck. The rfp mentions giving 2 sets of pricing (1) for the same graphics on each side of the trailers and truck and (1) for different graphics going on the both sides. My question is whether or not these are going to be full wraps, in that we are doing full coverage of the sides with wrap grade vinyl or if we are doing cut graphics. Could you please verify at your earliest so that I can get a quote out. Thank you.

A. 1. We want Full Wrap Color Graphics from one end to the other end of the trailer.

Q. 2. The rfp makes mention of removal of existing graphics. How long have the existing graphics been on the trailers and truck?

A. 2. We only have 1 Trailer that graphics need to be removed and it was a donated trailer I have no way of knowing when the graphics were applied. The year of the trailer is 2002.
